I would like to take this opportunity to recognize and thank the members of the Beautification Committee who worked very hard this year:

This committee was given the charge of determining what needed to be done in the neighborhood to improve it. We received most of our suggestions by talking to you, our neighbors. We then selected the items that were needed most.

I'm sure all of you can identify with the items that we recommended to the Board of Directors for the next two years:

Entry Sign Cleanup of the easement/emergency access path to apartments Identification of easements Landscaping of large common area Stairs for the easement between lots 31 and 32

We have received a number of estimates from area businesses concerning these areas and made the following recommendations for budgetary purposes:

First Year

- 1. A 3 1/2 by 6 foot double-sided redwood sign to be placed in the entry island with lights and some of the shrubs that currently exist there. The design unanimously chosen by the committee was the one which appeared on the River Oaks sales brochures.
- 2. A cement sidewalk 4 feet wide in the easement going over to the apartments
- 3. Small decorative fences at each corner of the apartment easement to identify the boundaries
- 4. Use the railroad ties given to us by Anden to buld stairs in the easement two the common areas behind the pump station.

Second Year

Landscaping of the large common area to include shade trees. The actual layout and design was not completed by this years committee.

This committee was not formed until the middle of this year, so you can see how busy everyone has been. I hope alot of you have signed up for next year's beautification committee.
