Beautification Committee:

So far 15 surveys have been returned. A large percentage of the homeowners do want grass in the common areas. There are still problems with dogs in the common areas from the apartments. It was suggested that a letter be sent to Inland Realty who owns the apartments and have them post it on their bulletin board. The survey results will be presented at the annual meeting.

Groundskeeper:

The letter was sent to Moonlighting no response has been received.

## mominating Committee:

There are only two nominees on the ballot. Hopefully there will be some nominations from the floor.

## City Liaison:

Linda reported two semi-trucks driving through the lower common area and leaving 12 inch deep ruts. She also called the police with the name and license number of the second truck. The police will follow-up with the trucking company, but they also recommend that we send a letter to the trucking company requesting payment for damages. Mike will follow-up with the letter. The police also recommended that there be parking on only one side of the street, especially down in the lower cul-de-sac area. Mike will inquire into that process.

#### Other:

Still no opinion has been received from our attorney regarding the retaining wall issue.

Linda acknowledged that the application for bonding of the treasurer, president and vice-president will be done after the next election.

Linda informed that board that the current insurance policy is for liability only and does not cover any damage to the property, such as the front sign or any of our trees. She is getting quotes on adding a rider to our current policy.

Dear Sir,

At this time we are accepting bids for the 1990 maintenance of our common areas here at River Oaks. For 1990, we will require expanded services.

In addition to mowing the grass the following services will be required:

- 1. The entryway of the subdivision will be landscaped in the early spring. This area will required special handling which includes:
  - a. hand weeding
  - b. removal of garbage
  - mowing of parkway (when new grass is ready)
  - d. mowing between Route 59 and the River Oaks property lines behind lots 1 and 66 (the state does not mow this frequently enough to keep the entryway clean)
- 2. The easement sidewalk between lots 51 and 52 will need to be better maintained this year, i.e.
  - a. removal of garbage
  - b. mowing of easement
- 3. The easement between lots 8 and 9 will need to be mowed this year. The homeowners will no longer be doing this.
- 4. In the upper common area:
  - a. the tree stakes must be replaced after mowing
  - removal of garbage, as opposed to being mowed over,
    i.e., wood, popcans and paper products.

We would also like bids on the following items which we may have done this year.

- 1. Planting of mums in the fall in the front entryway strip.
- Removal of bushes from the front entrance parkway.
- 3. Removal of pile of dead wood in the lower common area (by the river).
