There was an excess in actual assessments collected of \$1220. This was the result of all homeowners being current in their dues and of some homeowners having made payments for the next fiscal year. Landscaping increased in the actual budget due to additional work on the entranceway. Property maintenance is under budget because ROIA is waiting for the City to finish the remedial work on the

drainage pipes under the Common Area before the ROIA work on Common Area drainage can be started. Money to cover these costs will come out of the reserves when the work is eventually done. We are in the third year of a three-year contract for Common Area maintenance, so those numbers stay the same. The other increases are minor amounts including the post office box fee increase. The final amounts for the 2020/21 fiscal year will be finalized in a few weeks. Once that is done, the financial records will be sent to the accountant for the yearly financial review and the tax return for ROIA will be completed. These should all be completed in the next few months. A motion was made to accept the treasurer's report, including the budget proposal. The motion passed. The Budget will be approved by the Board of ROIA at the next Board meeting, as required by the By-Laws.

Election of Officers: Becky reported that 16 ballots were returned. Rich Thompson and Bill Price have been elected to serve 2-year terms on the Board. Rob thanked Susan for her chairmanship for the past several terms of her Board tenure.

Common Area Storm Drain and Sinkholes – Susan gave a summary of the on-going drainage remediation project that the City of Warrenville is doing. This involves cleaning and lining the storm sewer pipes under the Common Area that the City claims are City responsibility. This work was delayed to some extent due pandemic schedule changes. The pipes that the City says are River Oaks homeowners' responsibility will need to be done after the City finishes its work. Sharon Goodman reported that the City did some work in the area behind her house last fall and that she has some pictures of the work. Sharon also reported that the City did have a City-wide survey done last summer to check on City storm sewer systems and the presence of restrictors in the pipes, and that many of the restrictors that control storm sewer flow were missing. ROIA will check with the City to find out more information on the restrictor survey and exactly what work the City might still need to do in River Oaks.
