SEEKING OCCUPANTS

The River Oaks Board of Directors has begun its annual campaign to fill the three positions that will be vacant in 1992. These positions are for three year terms. By custom, Board members also serve as Committee Chairpersons.

The Nominating Committee has distributed a packet of information regarding nominations to these positions. The petitions included in these packets provide an opportunity for all River Oaks residents to nominate someone to become a member of the Board. When all of the petitions have been received, the Nominating Committee will then assemble and publish the slate of nominees. Voting will take place by secret ballot at the Annual Meeting, which will be held on the first Thursday of February, 1992. The persons receiving the most votes will be elected. The new Board will then elect its own officers.

So, think about who you'd like to nominate (including yourself) and submit the petition(s) to Toni Oster at 29W620 Ridge, or Ruth Brackman at 2S540 River Oaks, or Judy Molina at 2S510 River Oaks.

Petitions are due Friday, January 10, 1991. All nominating information will be kept confidential.

I No, no, guys - the homeowners are REBELLING. It's the PROPERTY TAXES that are REVOLTING!")

Once again a group of homeowners from River Oaks is banding together to appeal their real estate tax assessment increases. There was a meeting on Saturday, November 16th at the Nesbits' house to fill out the necessary forms for a joint appeal, as well as to discuss the approach to take with the Du-Page County Board of Review. A total of thirty homeowners joined the group appeal.

There are two major bases for this appeal. First, the 1990 sales figures for River Oaks suggest that we are beind assessed above the 33 1/3% level mandated by law. This overassessment seems to be a small amount this year, but it will be compounded by any luture increases. Second, the sales figures for "old Warrenville", i.e. those sections of the city not in a subdivision or individual assessment neighborhood, show that this area is assessed at a level of 28%, clearly below the required level. This is the basis for our equity appeal, that we are being "treated unfairly in the assessment process". as stated in the Rules of the Board of Review. The group of homeowners that met on Saturday agreed to be represented by Tom Sinnott and Becky Christiansen at the Board of Review hearing.

The Board of Directors of the homeowner's association in River Oaks is compiling a database of tax information that can be used in this year's appeal, as well as those that might be made in the future. Lists of sales of all single family homes in both Wheaton and Warrenville are included. We would like to thank Laurie Druyor, a realtor with REMAX Affiliates, 1600 Pebblewood Lane in Naperville, for her aid in getting us this information. We asked Laurie if she could get us sales information about Warrenville and Wheaton, and she surely did: 10 feet of computer printout in all! Thank you, Laurie, for all that time and paper!


SNOW FOOLIN' !

After several months of sporadic and largely unsuccessful attempts at negotiation, the City of Warrenville and the Anden Corporation will finally go to court on November 22 over the issue of River Oaks public improvements and landscaping. The case will be heard in the Circuit Court of the 18th Judicial Circuit, DuPage County. As you may recall, the City fled suit against Anden and its bonding company, American Motorists Insurance Company, on March 14, 1991 (see April 1991 Newsletter), alleging that Anden failed to complete numerous public improvements within River Oaks to the City's satisfaction, and that Anden failed to comply with City Ordinances 756 and 828, which require Anden to provide substantial landscaping along the north, west, and south boundaries of the subdivision and in the Common Area. We hope to have more news to report on these important developments in the next Newsletter

ROUTE 59 STUDY: WHAT THEY MIGHT DO

A study is proceeding with a long range plan for making Route 59 from 1-55 to Pilcher Road (just North of Plainfield) four through lanes, and from Pilcher Road to Route 72 (Higgins Road) SIX through lanes with additional right and left turn lanes, raised medians of various widths, including sidewalks on both sides of the road, and additional signals with some of them interconnected to provide more smooth movement. Some of this can be constructed in the existing right-of-way and some will need acquisition of additional right-of-way. The plans are available for review at City Hall.

A public hearing on the Route 59 Strategic Regional Arterial Study is scheduled for November 19 from 2 to 8 PM at the West Chicago City Hall. This is a public hearing with an Open House format. There will be repeated video presentations throughout the scheduled time to explain the project. Displays will be available for study and review and (DOT and consultants will be available to answer guestions. An opportunity will be provided for you to submit comments in writing or orally by tape recording.

FOX VALLEY EXPRESSWAY

The Public Information Office has opened in Warrenville. It is located in the 4-M Plaza on Route 59 and Ferry Road. You can review the plans that have been prepared by the IDOT consultants and have questions answered. The Fox Valley Expressway is a proposed North/South freeway that would be built between Routes 59 and 25. This is billed as a post 2010 project, but NOW is the time to voice your opinion about it. There is a questionnaire IDOT is encouraging citizens to answer and submit. This questionnaire was included in your Route 59 speed limit petition packet.





Tom Sinnott called the meeting to order at 7:45 PM.

OPEN FORUM: Becky Christiansen and Marnee Sinnott had a suggestion for the Entertainment Committee regarding the annual Halloween party. They felt that the Halloween party is an inappropriate expense, and that a different form of Halloween observance, such as the Halloween parades we have had in some previous years, would be preferable. There are at least 1/3 of the homeowners who reside in River Oaks who do not have children and don't participate in the party, and their dues do help pay for this event. They would like the Board to have the Entertainment Committee review this idea.

The Board agreed that next year's Entertainment Committee would be passed along this suggestion and the new Committee would take this under advisement.

TREASURER'S REPORT: Gloria was absent. Much discussion was on on delinquent accounts, and whether small claims court action is advisable. Also the mortgage company for the delinquent accounts will be contacted.

Tentative budget figures were given and work on the budget is proceeding.

ENTERTAINMENT COMMITTEE: Linda stated the party was on track, and looked like a good turnout could be expected by the amount of candy that has been donated. This ends the Entertainment Committee's planned activities for 1991.

CITY LIAISON: Amy wrote Officer Van Wankum a thank you letter for speaking at a previous Board meeting.

NEWSLETTER COMMITTEE: John requested and obtained Board approval to send our newsletter to other homeowners associations starting with the

October issue.

NOMINATING COMMITTEE. Toni has reserved the Johnson School multi-purpose room for our Annual Also, this committee will be soliciting Meeting. nominations for three open Board slots. John's, Gloria's and Linda's terms are up in 1992. Toni moved that discussion be held on the proposal that Board members' terms of office be for only two years instead of three. Much discussion was had on this proposal; it was decided to table this issue for the time being. An ad hos committee was formed, composed of Tom, Cheryl, and Linda, to study the River Oaks Bylaws and Covenants to see if and how this could be done. It was felt that a shorter term may encourage more people to run for the Board. Cheryl will be asked to write other homwowners associations to request copies their bylaws & convenants.

GROUNDSKEEPING/BEAUTIFICATION COMMITTEE: No redort.

OLD BUSINESS: The City has given its approval for River Oaks' parkway tree planting proposal.

The judge in the City of Warrenville's lawsuit against Anden has directed Anden and the City to meet and try to reach an agreement. There is a whole new cast of players from Anden as everyone has left that was working on this issue for the last year or more. If Anden and the City cannot reach an agreement, the case will go to court soon.

Tom read a letter that Police Chief LaDeur wrote to IDOT regarding the campaign of "selective enforcement" of the speed limit on Route 59. The campaign is now offically over, and IDOT will hopefully do another Route 59 speed survey shortly.

NEW BUSINESS: Tom will have a meeting of the ad hoc bylaw committee at his home on November 14th

Mark Moore has volunteered to fill Karl Berland's open position on the Board and serve out the rest of the term, which expires in 1993. The Board voted unanimously to accept.

The meeting was adjourned at 10:30 PM. The next Board meeting is scheduled for 7:30 PM, Thursday, November 21, at the Langstons'.
