Tom called the meeting to order at 7:40 P.M.

**Motion:** Bryan made a motion to accept the minutes as written. Joe seconded the motion. The motion passed.

Treasurer's Report: Joe reported that the PO Box for ROIA is the same as the one we have always had, and that dues should be mailed to that address. The accountant is nearly done with the review. The register ending balance is \$10, 379.82.

**Motion:** Mark made a motion to accept the treasurer's report. Becky seconded the motion. The motion passed.

Entertainment: Bryan presented the Board with the questionnaire the Entertainment Committee would like to distribute. Bryan will take the questionnaires door to door and will return to each home to pick them up on the weekend. He will try to compile the results for the June Newsletter.

City Liaison: Chuck was not present. He has reported that he is checking on the arrangements for the drain digging. Mark reported that he has spoke with Tom Fox from the City of Warrenville about the waste oil that has damaged another area of grass in the Common Area once again. The City believes that some unknown individual is dumping used oil down the drain behind the shopping center. It

is unlikely that the culprits can be found unless they are caught in the act.

Landscaping: Tom has contacted Brickmann not to mow the Common Area during the 6/23 weekend, because of the draught and lack of growth. He thanked Mary Moore, who led a team of weeders at the Common Area entrance planting last weekend. Her helpers included John Christiansen, Mark Moore, and Tom Sinnott. Tom also thanked Arthur Kreymer for his donation of dirt to fill in the hole at the top of the river bank hill. Tom will be contacting a supplier for an estimate to deliver large rock to fill a crescent shape on the back side of the lower cul-de-sac circle. The overburden could be used for a berm in the circle, which could be planted with the shrubs that need moving. The weekends of July 8 and July 15 are scheduled for a work party to work on the stairs in the Common Area. The first weekend will see the removal of the old stairs and the setting of new anchoring posts. The following weekend will be the time when the new stairs and built.

Newsletter: Mark intends that the Newsletter come out during the 7/2 week. He will include a note that the PO Box has not changed. He will also include a reminder that parents should remind their children to not trespass in other people's yards.

#### **Old Business:**

Car Problem: The other car being stored illegally in a back yard in the subdivision has not been moved. It was agreed to let the City handle the matter in accordance with the ordinance regarding this situation.

**Motion:** Mark made a motion to adjourn the meeting. Tom seconded the motion. The meeting adjourned at 9:15 P.M.



Unfortunately there has been a little confusion about our mailing address. The result of that confusion was some people thought we had to change our PO Box number.


Fortunately, it was only confusion, there is no change in the mailing address for River Oaks Improvement Association. We apologize for the confusion. Is anyone confused?

It's impossible to act in the best interests of the community unless we know what the community is thinking. For those of you who did not have the opportunity to fill out the questionnaire, please feel free to either fill it out and drop it off at the Lynch's. Or better still, come to a committee meeting.

Now, as to the questionnaire. Allow me to give a little background. Though my family and I have lived here since 1991, I hadn't had the opportunity to participate in ANYTHING here in the community in that time, since I was touring with several Broadway shows. I had heard of some things that happened, some events that were tried, some that continued and some that did not. I honestly did not know what the community as a whole wanted, whether things were discontinued through lack of interest, lack of time, or lack of funds. As far as I knew, the entertainment committee could be anything from the organizing group behind one annual event to a social focal point for the community, one that would have several functions throughout the year. It all depended on what the community wanted. Hence, the questionnaire. Well, here's what I found out.


Of the 49 households that responded, an overwhelming majority said they wanted the Taste of River Oaks to be a pot luck, as had been done in the past. Since this type of event is, by nature, extremely cost effective, it is understandable how the community answered the question concerning the budget. An overwhelming majority split their votes

between keeping the budget the same and/or having participants pay any extra on a per-event basis. As one homeowner stated, the many should not have to pay for the few. (I know I'm doing this in the reverse order, but it seemed more logical to me this way.) In response to the first question, there were many things that people were interested in seeing here in the community, things that could easily be paid for on a per-event basis. The top vote getters were Taste of River Oaks (32), the Easter egg hunt and group excursions (17 each), a Christmas party (17), and a Halloween party and Christmas caroling (12 each).





Thanks to everyone who participated in the survey for your information and comments. There were, however, a few people who made comments about large expenditures on common area and parkway trees. The Board is very concerned about this continuing disinformation and resulting confusion. The costs regarding common area, & Parkway Trees have been discussed at several board meetings, Landscape committee meetings and Annual meetings, and have been published many times in the Newsletter.

To keep it short and sweet, here are the actual tree expenditures for the last three years; 1993 - \$40.00, 1994 - \$0.00, 1995 - \$25.00. These costs cover <u>all</u> of the well over 300 trees planted in the common areas, parkways, screening areas, and in the tree nursery.


