This money was donated to the Warrenville Youth and Family Services to help needy area families this holiday season. A thank you letter was received by ROIA from the WYFS. The Board would like to thank Kelly very much for her hard work to make this a successful project.

Budget: Since no responses have been received as of the current date to the bid requests for the Common Area maintenance for the next year, the Board agreed to postpone preparing a budget at this meeting. The Board will meet on Sunday, December 10, 1995, for a special budget preparation meeting. This budget will be published in the next Newsletter for homeowner review.

But since then reality has set in and the rates have been steadily increasing. To counter this we have been finding economical ways to lower the cost of printing and mailing the dues cards, publishing the newsletters, bank charges, treasurers expenses, and annual meeting expenses.
