## Minutes Board of Directors Meeting

Motion: Bruce made a motion to accept the minutes as written. Brian seconded the motion.

The motion passed.

Treasurer's Report: Joe reported the register ending balance as of 12/15/96 is \$13,032.05. Joe asked the Board to approve the transfer of \$10,000.00 into a money market account for 90 days. Interest rate on this particular account is currently paying 4.69 %. Attempting to have our money earn more for the Association has been under discussion by this Board and the previous Board. This is the time of year when our coffers are the greatest because we are not paying out large amounts for Common area mowing. Bruce made a motion to transfer the aforementioned monies to a money market account for 90 days. Brian seconded it. The motion passed.

Entertainment: No Report.

City Liaison: The City completed the new sewer line in the Lower Common area entrance. Since it was late in the Fall when this work was completed, the City was unable to clean up and re-seed the work area. This will be finished in the Spring.

New Business: The Board will have four positions to fill at the next annual meeting. Bruce was asked to begin contacting potential candidates. This was discussed again by the present Board and it is hoped that volunteers will come forward so that this move will not be necessary.

#### **Xylitol for Your Ears**

The British Medical Journal reports that chewing gum containing xylitol can cut the number of childhood ear infections in half. Xylitol is a sweetener found in corn cobs, straw, and birch and maple trees. It is not useful as an energy source to bacteria that cause tooth decay and, apparently, many ear infections. Researchers gave gum five times a day for two months to preschoolers, who chewed the gum for a relatively short time before disposing of it. Another group was given normal sugared gum to be sure the effects were not simply due to increased ventilation to the eustachian tubes.

Motion: Bruce motioned to adjourn the meeting. Andy seconded. The motion carried at 9:45 P.M.


