Workday at Country Ridge

There will be a workday at Country Ridge Apartments on Saturday, June 6th starting at 9:00 am (meet in front of the 538 building).

The plan is for residents and owners to meet with Cub Scouts/Boy Scouts and any other volunteer in an effort to clean debris and to instill a sense of pride in the appearance of the complex.

Also, "wayward" grocery carts will be returned to Family Foods, and an attempt will be made to trim or remove dead trees and bushes.

Finally, the Fire Department will be present to clean the retention pond.

This project is of special interest to River Oaks residents because the Country Ridge Apartment complex is an immediate neighbor and beautification of this property will positively affect us. But we are also affected by this effort because of the storm water drainage. You may have noticed that our common area gets filled with debris following a heavy rain. This is because scraps of paper, etc. that is on the apartment complex property gets washed into the storm water drainage system, and it later surfaces in our retention areas. The cleanup effort should reduce the amount of this debris.

The project is being spearheaded by Officer Dave Schar (who is to be commended!). He plans to make it an annual event.
