Sign Update

The entryway sign project has been progressing with several changes that have been required. As mentioned in the last Newsletter in April, the plans originally called for 2 four-foot-high and eight-foot-long brick signs to be erected on either side of the entryway. Since that time, the Board of Directors has been informed that it is unable to place a sign on the north side of the street. This leaves the south side of the entryway as the only location possible for the new sign.


In order to be visible to both north- and south-bound traffic on Rt. 59, a two-sided design is necessary. The current plan is for a V-shaped sign to be placed in the City's Right of Way that exists on the south side of the intersection, east of any encroachment in the State ROW. Each side of the "V" will be four feet tall and eight feet long.

As has been mentioned previously, the placement of an entryway sign is subject to City approval. Major concerns involve traffic visibility and utility easement clearance. The engineers that checked the suggested placement for the City have cited the problem of visibility caused by the current sign in the center island. So simply replacing the current sign is not an option.

Once the sign has been approved, it can be built. Then a professional landscape designer can be hired to draw up a landscaping plan to create a completed entryway effect.

We will keep you updated on the latest developments regarding the sign as soon as they are available.
