



Treasurer report: Only \$300.00 left owing for 2006. Discussion was held regarding when to apply late fees. Linda will look into old files for exact wording on late fees and liens. Discussion was started again about the retaining wall. One homwowner has paid the \$1000 and one homeowner has paid a partial of the \$1000. Board is discussing whether to keep these monies or return to homeowner.

Ruth will contact Bob Siebert to look at wall as he expressed interest in the past to reconstruct at a reasonable price.

Also DuPage Storm Water will be contacted to understand just how much the lower bowl must retain per their standards.

Rick will give Sowa's association letter for closing.

Treasurer's report was read and Linda made motion to accept, Robin seconded.

We will forgo the Black eye Susan project this year as we received the notice and did not have time to spread the word, maybe next year.

We will ask Pete to talk to Brickmann again, as they are still sporadically missing some mowing areas. Stairs that lead to river are in need of repair, should we fix or just take out was the question. Tabled for later after the rest of the board has a chance to go look at them.

John Wills will be a guest at next month's meeting. He is the city rep with Tronex. We will walk to the bottom area to see just how much is involved and how many trees we will lose.

Block party date will decided at next meeting, probably in mid-September.

Motion was made to have a haul route in the lower common area doe river cleanup to allow access. This will go in a loop from the river bed and back to the river bed, no trucks in the subdivision streets.

On a future date John Wills will come back to discuss the restoration of the lower common area. Robert made the m0tion and Robin seconded.

Pete is following up with Brickman, Ruth showed the crew some items missed in certain areas.

Front entry light bulb needs to be replaced.

Neighborhood Watch needs to be revived. Drug deals at the end of the sidewalk from the apartments into the subdivision have been noted and police have been notified. More lighting may be a deterrent. We will approach the city.
